In Connecticut:

- Most individuals insured by HUSKY Dental have no way to pay for the treatment of gum disease.
- Two-thirds of children in the third grade do not have dental sealants to protect against tooth decay.
- Adults with serious untreated oral health issues are more likely to miss work.
- Children experiencing dental pain are more likely to miss school and have poor academic outcomes.

People of color and those with lower incomes have been more impacted by these problems. With your support, COHI can combat oral health disparities by ensuring equity, increasing accessibility, and improving upon quality of dental care.

In 2022, COHI successfully led advocacy campaigns that accomplished the following:

- For the first time in 14 years, Medicaid adult dental reimbursement rates were increased by 25% with an additional increase for endodontic services.

- A second annual dental cleaning has been covered for Medicaid recipients who have medical conditions that can be worsened by poor oral health.
- Medicaid coverage of silver diamine fluoride (SDF) treatment was expanded so patients of any age can have increased access to this non-invasive procedure that arrests tooth decay.

This year, COHI also published two major reports on oral health care in Connecticut:

- “A Medicaid Gap Analysis of Oral Health Care for Adults in Connecticut” identifies the barriers to obtaining dental services among HUSKY recipients.
- “Every Smile Counts: The Oral Health of Connecticut’s Children” documents the oral health inequities that prevent kindergarten and third-grade children from reaching previously established oral health goals.

In 2023, COHI will focus on the following areas:

Continuing expansion of HUSKY Dental to cover needed treatment.

- Increasing access to dental care for Medicaid recipients.
- Supporting oral health care for low-income individuals receiving treatment at Federally Qualified Health Centers (FQHCs) and School-Based Health Centers (SBHC).
- Furthering workforce initiatives to diversify the dental field.
